### ***Ways to Make a Lasting Investment***

Many people are thrilled to discover that including a gift to Mully Children's Family in their will, or other planned giving options, can significantly impact the lives of children in need while advancing God's Kingdom.

You have numerous ways to invest in MCF, but here are a few gift suggestions for your consideration:

## ***Leave a Gift in Your Will***

Designated gifts to MCF in your will are the best sources of sustained support because unrestricted gifts give MCF the greatest flexibility to use funds where they are most needed.

### ***You may leave Mully Children's Family:***

- A stated dollar amount
- A percentage of your residual estate (this is what remains after gifts to family and loved ones and expenses are paid)
- A specific asset such as securities or other marketable property

***This sample language maybe helpful:***

I give and bequeath to Mully Children's Family USA, Inc, a not-for-profit corporation, Tax ID # 20-4105702 current mailing address 3000 Old Alabama Road, Suite 119-302, Alpharetta, GA, 30022 [the sum of \_\_\_\_ Dollars (\$\_\_\_\_)] [\_\_\_\_% of the rest, residual and remainder of my estate], to be used for its general charitable purposes.



## ***Name Mullly Children's Family as a Charity Beneficiary***

Naming Mullly Children's Family as a beneficiary on your retirement account or life insurance policy is a simple way to support the lifesaving work of MCF without changing your will. Beneficiary gifts pass directly to MCF without going through the probate and can go right to work supporting MCF.

### ***A) Retirement Accounts (401k, 403b, IRAs other retirement plans)***

Individuals who inherit retirement plan assets are usually required to pay income tax on them, so they are often considered among the best assets to leave to a charity. MCF can be named as a beneficiary of all or a specific percentage of your retirement plan.

Ask your retirement plan administrator or financial institution for a change of beneficiary form.

## ***B) Life Insurance Policies***

MCF can be named as a beneficiary of all or a specific percentage of a life insurance policy which is no longer needed to support your family.

Ask your life insurance agent or insurance company for a change of beneficiary form.

## ***C) Bank Investment Accounts***

You can leave a legacy by naming MCF as a Transfer-on-Death (TOD) or Payable-on-Death (POD) beneficiary on a bank or investment account. Check with your financial institution to see if this option is available to you.
